## **GUIDELINES AND CODE OF CONDUCT**

The statutory safety regulations and accident prevention regulations of the commercial employers' liability insurance association apply on the company premises of the companies of the BLANC & FISCHER Family Holding. The most common markings are listed and explained below. These must be observed at all times.

Wear safety shoes and safety vests on the factory premises, especially in the loading and unloading area.

Observe the warning notices in the triangle highlighted in yellow.

Entering the premises where no work is to be carried out as part of the work order is prohibited! Switching operations on all

installations are only permitted

after approval by the person authorized to switch.

Photography and video and film recordings are not permitted. Exceptions must be approved in advance.

Open flames and flammable work (e.g., welding, cutting, grinding, and soldering work) are prohibited. A permit must be applied for and approved for exceptions.

Smoking is strictly

prohibited on the factory premises, except for designated locations.

The consumption of alcohol and intoxicants is prohibited on the entire factory premises.

Persons with active or passive medical devices must stay away from installations or areas labeled accordingly.

Always pay attention to truck and forklift traffic.

The rules of the road traffic regulations apply to the factory premises. Inform your contact person immediately in the event of an accident.

The statutory provisions for environmental protection apply on the premises of the plant. Dispose of waste in accordance with the packaging ordinance.
